

#### **NOTICE TO EXHIBITORS**

The Border Terrier Club of America offers a rosette to each dog who earns a qualifying score in a regular class and an enameled pin with the BTCA Specialty logo.

Any dog qualifying in the Introduction to Quarry class shall be awarded a light green qualifying ribbon.

Only dogs with a Master Earthdog title at the time of the test will be allowed to run in two (2) regular classes (Master and Senior). All other dogs without a Master Earthdog title can run in a single regular class (Junior, or Senior, or Master) and Intro.

Move-ups: Move-ups will be allowed until 6:00 PM May 31, 2021 for regular classes. Move-ups will be allowed from Junior to Senior and Senior to Master. If the dog is moving up from Master to EE, and the owner wishes to enter both Master and Senior, an additional entry fee of \$25.00 will be required. This payment must be received before the dog is checked in for the test. E-mail move-ups to the Test Secretary, Nancy Goldman, at

Goldmann@mindspring.com with the dog's name, the original class dog was entered in, the handler/owner's name, and class you want the dog moved to. Dogs must be at least six months of age. Spayed, neutered, limited registration, PAL/ILP border terriers are eligible to enter.

Bitches in Season: Bitches in season are not eligible to participate. Bitches in season are allowed at the general test site but shall not be allowed to distract other dogs during the test hours and shall not be allowed within 100 feet of any testing area during the running of any class. Entry fees for bitches in season will be refunded (less a \$5.00 fee) if the Test Secretary is notified in writing by day of test, June 6, 2021, at 8 am.

No substitutions or refunds will be made after the entry closing date has passed.

**Notice about Limited entries:** Since the entries for SE & ME are numerically limited, the first 30 SE dogs and 24 ME dogs received will be entered. Once these entries are filled for these two classes, a waiting list will be started and utilized if cancellations are received. Wait list entries will be notified for full refunds if not used.

### **Running Order:**

Dogs in Intro to Quarry, Junior, and Senior Earthdog classes will run in the order entries are received. Multiple entries by the same owner/handler will be separated to expedite smooth running of the test. Volunteers assisting in the trials may be placed at the beginning of the running order. The running order for each class will be posted prior to the start of each class. The judge will not wait for late arriving dogs, but every effort will be made to accommodate conflicts by moving dogs to the bottom of the list as necessary. The Test Committee or the judges may modify the running order to expedite the running of the test.

Dogs entered in Master Earthdog must check in with the Test Secretary no later than 7:30AM. . Only those dogs present will be deemed starters and will be entered in the random drawing for the Master Earthdog class running.




#### **Directions:**

<u>From North</u>: Route 287 South, Exit 52B, Rt. 23 North, to Route 94W. Make a Right to Route 15 North to Route 206 North, 1 mil. Take right on Plains Rd. <u>From Route 84</u>, (NY & PA): use Milford Exit. Route 6 East to Route 209 South. Cross Bridge. Route 206 10 mile South to Plains Rd.

<u>From Route 80, Westbound (NYC & NJ)</u>: use Exit 34B, Route 15 North, to Route 206 North, 1 mile to right turn on Plains Rd. .

### CAMPING/RV PARKING RESERVATIONS

All RV/Campers staying overnight at the Sussex Fairgrounds must make reservations and park in their assigned spaces. The parking area will be restricted to RVs, campers, guests and their dogs only. Parking will be available from Saturday, June 5, 2021 through Friday, June 11, 2021.

The RV site is in close proximity to all planned activities. Parking areas will be on gravel or grass with some on paved roads. Electric is available at all sites, water at most, though it can be shared between spaces. There are restrooms with showers near the RV site.

There is a dump station at the Fairgrounds. Specifics as to fees and directions for dumping will be included in later communications. Spaces will be assigned according to size, space availability and the order in which reservation forms are received. If campers wish to park together, please indicate that on your form. We will do everything we can do to accommodate your request; however, we can make no guarantees.

If you plan to use a generator, please use an exhaust system with an extension to reduce fumes.

Parking reservations must be received by May 12, 2021. The parking fee charged by the Fairgrounds is \$50.00 per night.

RV parking funds refunds will not be made after the close of entries. Please make your reservations early.

# Border Terrier Club of America, Inc Room Responsibility Policy

The Border Terrier Club Of America has adopted the following rules in order to ensure that its members and their dogs will be welcome at hotels in the future. Any individual attending a BTCA sanctioned event and staying in a hotel, motel, inn or campsite/fairground has the responsibility of leaving that room or campsite exactly as found. This includes picking up after dog(s) on the grounds. Anyone who damages a room or campsite/fairground and does not report the damage to the hotel/campsite/fairground man- agreement and make immediate restitution or arrangements to do so within a period agreed upon by the management, will be subject to any or all the following actions by the BTCA Board of Directors.

- 1.. May be banned from showing at the next BTCA sanctioned event(s).
- 2. May be subject to AKC sanctions.
- 3. Membership in the BTCA may be terminated and may not be allowed to be reinstated.

Damages shall be defined as:

- 1. Flea infestation, urine, defecation and/or any damage to hotel/campsite/fairground property (walls, bedspreads, carpets, drapes, etc.).
- 2. Any verified complaint by the host hotel/campsite/fairground. 3.

Any verified complaint by a GTCED member.

#### BTCA Room Regulations:

 All dogs shall be crated and quiet when left alone in a room. Noisy dogs shall

be quieted upon request, even if this means the owner/handler must stay in the room with the dog.

- Individuals will be expected to immediately report any damage by dogs or themselves to the hotel/campsite/fairground management, and to assume complete financial responsibility for those damages.
- 3. No bathing or grooming will be allowed in rooms. A grooming room will be available when- ever possible.
- 4. Dogs are to be allowed on hotel furniture/beds ONLY if the furniture is covered with

protective covering provided by the owner/handler. 5. All owners/handlers will take preventative measures to assure that their dogs are free of fleas, mites, intestinal parasites and other communicable diseases prior to arriving at the hotel/campsite.

THIS POLICY WILL BE INCLUDED IN THE SPECIALTY GUIDELINES AND BE REQUIRED TO BE INCLUDED IN THE PREMIUM LIST WITH THE UNDERSTANDING THAT SIGNING THE ENTRY FORM ALSO INSURES COMPLIANCE WITH THIS POLICY. THE POLICY WILL ALSO BE INCLUDED IN THE SPECIALTY PACKET MAILED TO MEMBERS AND WILL BE DISTRIBUTED WITH SPECIALTY HOSPITALITY PACKETS. ALL INDIVIDUALS ARE REQUIRED TO COMPLY.

#### **COVID-19 Operating Guidelines**

The Border Terrier Club of America organizers will comply with AKC, state and local government and public health authorities to determine Covid risks and mitigation factors. At this time, these are the advised guidelines. These guidelines may be revised as circumstances dictate.

#### On Site Process and Procedures

Border Terrier Club of America, Inc. shall require temperature monitoring for volunteers, officials, exhibitors, and service providers once daily prior to entering the event areas. Anyone with a temperature of 100.4 or higher will not be allowed to enter the event areas. Everyone entering showgrounds will be required to wear a mask. Signage to this effect will be posted at the entrance and throughout the grounds.

The following individuals will not be permitted on the show grounds:

- An individual who exhibits COVID-19 symptoms
- An individual who has tested positive for COVID-19 within last two weeks
- An individual who has been in contact with someone who has tested positive for COVID-19 within the last two weeks.

All Speciality participants will be required to sign a Border Terrier Club of America INC. Health Acknowledgement & Liability Waiver in order to remain at our scheduled events

### **COVID-19 Operating Guidelines**

The Border Terrier Club of America organizers will comply with AKC, state and local government and public health authorities to determine Covid risks and mitigation factors. At this time, these are the advised guidelines. These guidelines may be revised as circumstances dictate.

#### On Site Process and Procedures

Border Terrier Club of America, Inc. shall require temperature monitoring for volunteers, officials, exhibitors, and service providers once daily prior to entering the event areas. Anyone with a temperature of 100.4 or higher will not be allowed to enter the event areas. Everyone entering showgrounds will be required to wear a mask. Signage to this effect will be posted at the entrance and throughout the grounds.

#### The following individuals will not be permitted on the show grounds:

- An individual who exhibits COVID-19 symptoms
- An individual who has tested positive for COVID-19 within last two weeks
- An individual who has been in contact with someone who has tested positive for COVID-19 within the last two weeks.

#### Signage

The Border Terrier Club of America, Inc. will post signage that displays all applicable federal, state and local regulations, requirements and orders as well as WHO recommendations and CDC guidelines as they relate to mass gatherings and sporting events in effect at the show.

Signage will be posted at all entrances to the show grounds which identifies the symptoms of COVID-19 and states the following:

- To protect others from possible transmission of the virus, anyone who exhibits COVID-19 symptoms or has been in contact with someone who has tested positive for COVID-19 within the last two weeks (exception, healthcare personnel who have treated patients using appropriate medical-grade PPE during the course of performing professional duties), cannot enter the show grounds. These individuals are encouraged to contact their health care provider immediately for further medical advice and must obtain documented clearance from their health care provider before entering the show grounds. Participants must assume responsibility for themselves and their own staff (e.g. assistants, etc.).
- Recommendations about good hygiene along with informing participants and others about ways to reduce the risk of COVID-19 transmission.

#### Social distancing and limiting entries

- The Border Terrier Club of America, Inc. shall enforce social distancing requirements throughout the showgrounds at all times.
- · Prohibit the public and non-essential personnel from being on the show grounds. Non-participants may watch from outside the tent with proper distance between spectators but will not be allowed inside the tent.
- · Organize dog and exhibitor arrivals and departures to limit contact between people, exhibitors must leave the tent immediately after showing and cannot return unless they have another dog to show or need to return to the ring with their dog.
- · Arrange judges' and other officials' areas to comply with social distancing requirements.
- Restrict show officials and judges' areas access to essential personnel only. Limited entry will be considered if necessary. Regardless of the scope of the limitation, the limiting of entries must be

done on a first come, first served basis and relevant information will be posted on the Show secretary's Website.

#### **Enforcement Authority:**

Stewards, Club Officials and AKC officials will inform individuals when they are not in compliance with the regulations and requirements in effect at the show and shall report such situations to the Club Officials and AKC. The Border Terrier Club of America has the authority to remove from the facility any person who does not comply with the regulations and requirements in effect.

If an individual needs an accommodation under the American Disabilities Act, a request should be submitted, along with documentation of the disability and need for accommodation, to Nina Fetter, Executive Dog Shows. Requests for accommodations will be reviewed on a confidential basis with a medical consultant. Participants are required to comply with these and any additional Show Organizer requirements at all times while present on show grounds. Failure to do so may result in expulsion from the grounds. These requirements are in effect immediately and until further notice, however, they are subject to revisions as the COVID-19 environment changes.

#### Recommended Best Practices Covid-19

The following Recommended Best Practices have been provided to assist Show Organizers with determining risks and developing measures to mitigate those risks:

- · Limit the number of entrances and exits to event areas to manage the number of individuals accessing event areas.
- Communication Use radio, cell phone communication methods as much as possible and communicate important information frequently throughout the show grounds.
- Provide markers to delineate 6 feet spacing between people in any waiting lines.

#### **Armbands Procedure**

- · There will be tables set up by class to pick up armbands. Please allow for extra time to get your armband.
- · Please do not gather around the tables.

#### **Parking Considerations**

- Parking area will be maintained completely separate from the show area. RV parking is separate from regular auto parking.
- RV's will be parked facing the same direction to ensure maximum separation of RV entrance/exits.
- · Automobiles will be parked in a separate area and will be parked no less than 6 feet apart.

#### Considerations for Club Members, Medical Personnel, Service Providers & Volunteers

- Cleaning/Sanitizing Locations will be provided with access to soap and water or alcohol-based hand sanitizer at several areas through the grounds.
- · Hand sanitizer will be provided to all officials, ring crew, clean up and medical officials.
- There will be frequent cleaning and sanitizing of bathrooms. Soap and water or alcohol-based hand sanitizer will be provided in bathrooms.
